## 11. Authority for signing orders for payment:

The authority to authorise the Council's appointed bank (HSBC) to honour all cheques and other orders or instructions signed on behalf of the Council by two members & the clerk was mandated. Current authorised member signatories (currently under application) are Councillor David Seddon & Councillor Sarah Calvert with the Clerk's application also awaiting approval.

The clerk advised council that advice had been taken regarding Bob Hazlehurst continuing to make payments on behalf of the council in the interim. Legal advice given was that Bob Hazlehurst should be made a casual employee in order to continue duties. The Clerk informed council that a further enquiry had been made to request Bob Hazlehurst act as a sub-contractor but was still awaiting feedback. Council noted they would prefer this option but would follow the legal advice. Bob Hazlehurst wished to state that he would prefer to perform these duties free of charge.

The clerk also explained to council the benefits of a debit card for council use as this would eliminate the need for the Clerk to use a personal card for purchases and then reclaim. Council resolved to support this. The Clerk would apply for this service once authorised as a user.

### 12. Outside bodies:

A list of representatives for outside bodies was considered. Councillor Patrick Heesom suggested sending invitations out to all members from outside bodies in the interim until new council expressed their preferences. Members commented on the merits of attending the Quarterly West Flintshire Town and Community Council Working Group Meetings. It was resolved for the Clerk to make enquiries with Ysgol Maes Pennant to ascertain requirements.
